DESCRIPTION

We will discuss recent changes to Kansas statutes such as Rule Against Perpetuities, Trust Decanting, and Small Estate Affidavit amount. Additionally, the Jackson County Probate court will provide the most up to date information to attorneys to appropriately redact probate specific pleadings to continue to comply with the existing rule that went into effect on July 1, 2023. The new redaction rule heightens the importance of existing requirements for anyone filing documents in any Missouri state court (lawyers, court staff, parties, etc.) to keep confidential information out of public documents.
