## Student Law Academy 2023: That's a Wrap!



We had 33 students, rising juniors, and seniors in high school who were selected to participate as scholars in KCMBF's Student Law Academy (SLA) **Legal Pathway**. The largest class of scholars to date, the 2023 SLA program launched on June 5th, 2023. Each weekday morning throughout the month, SLA Scholars interacted with legal professionals on various legal topics. They spoke with judges, heard from lawyers from all areas of law, and learned about the justice system and different careers in the law. The students attended a total of 54 sessions with 68 speakers. Thank you to our wonderful volunteer presenters who provided great sessions for the students. The graduation was held on June 30th at UMKC School of Law, and Hon. Candice Alcaraz was the inspirational keynote speaker.

We were also thrilled to continue the SLA **Job Shadow** this year. SLA graduates from past years' Legal Pathway program enjoyed an in-person rotational, paid internship opportunity and mock trial experience from July 5-28, 2023. Scholars were assigned and worked with mentors and attended field trips to the Kansas State Capitol, the Kansas Supreme Court, United States Courts-Western District of Missouri, and the Missouri Court of Appeals-Western District. The Job Shadow program ended with a Mock Trial and Ice Cream Social at the KCMBA headquarters!

All SLA graduates are eligible for the **Pre-Law Fellowship**, which provides resources and mentorship for those applying to law school or other legal-related professional schools.
